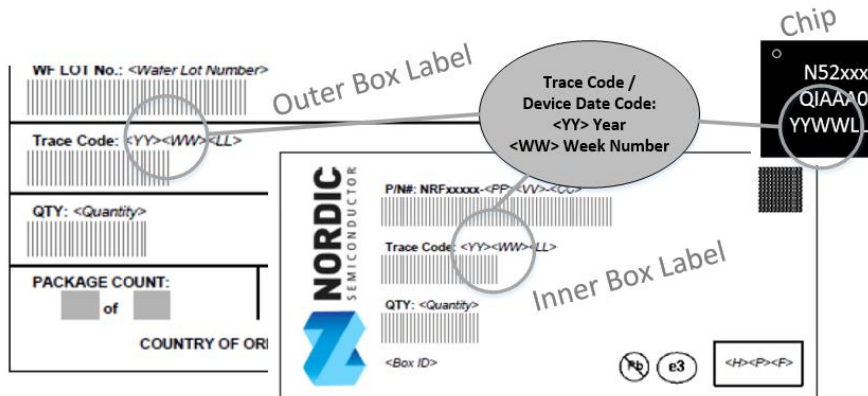
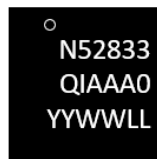

<p>Reason for change:</p> <p>Affected devices have been found to have a possibility of going through an unintended reset when entering System ON IDLE state at supply voltage (VDD) above 2.8V while also operated at temperatures below 0 degrees Celsius. The probability of such instances of reset behavior has been observed to be between 1 in 300 000 (at -40 degrees Celsius) and 1 in 20 000 000 (at 0 degrees Celsius), i.e. relative to the number of transitions to the System ON IDLE state. Devices that experienced reset resumed normal function after reset. The change ensures that the described reset behavior is no longer observable. The described behavior has not been observed at supply voltages below 2.8V or at temperatures above 0 degrees Celsius.</p>
