LXES15AAA1-017/075/100/112/117 includes the trivalent chromium (Cr) as an ingredient, which become an object for the Murata environment regulation policy. At the same time, the new calcination furnace setting is also considered, as it gets aged to work. Since the ingredient for Ceramic ESD without Cr have already in MP and succeeded cost reduction, we are planning to stop using the Cr-containing ingredient, which leads to the EOL of these items.
