




PACKAGE DIMENSIONS







SPATIAL DISTRIBUTION



BLUE




REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS






- Don't cause stress to the LEDs while it is exposed to high temperature.

REEL DIMENSION (units : mm)


