








**RECOMMENDED SOLDERING PATTERN**






#### SPATIAL DISTRIBUTION








#### Luminous Intensity vs. Ambient Temperature




#### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**



#### REEL DIMENSION (units : mm)


