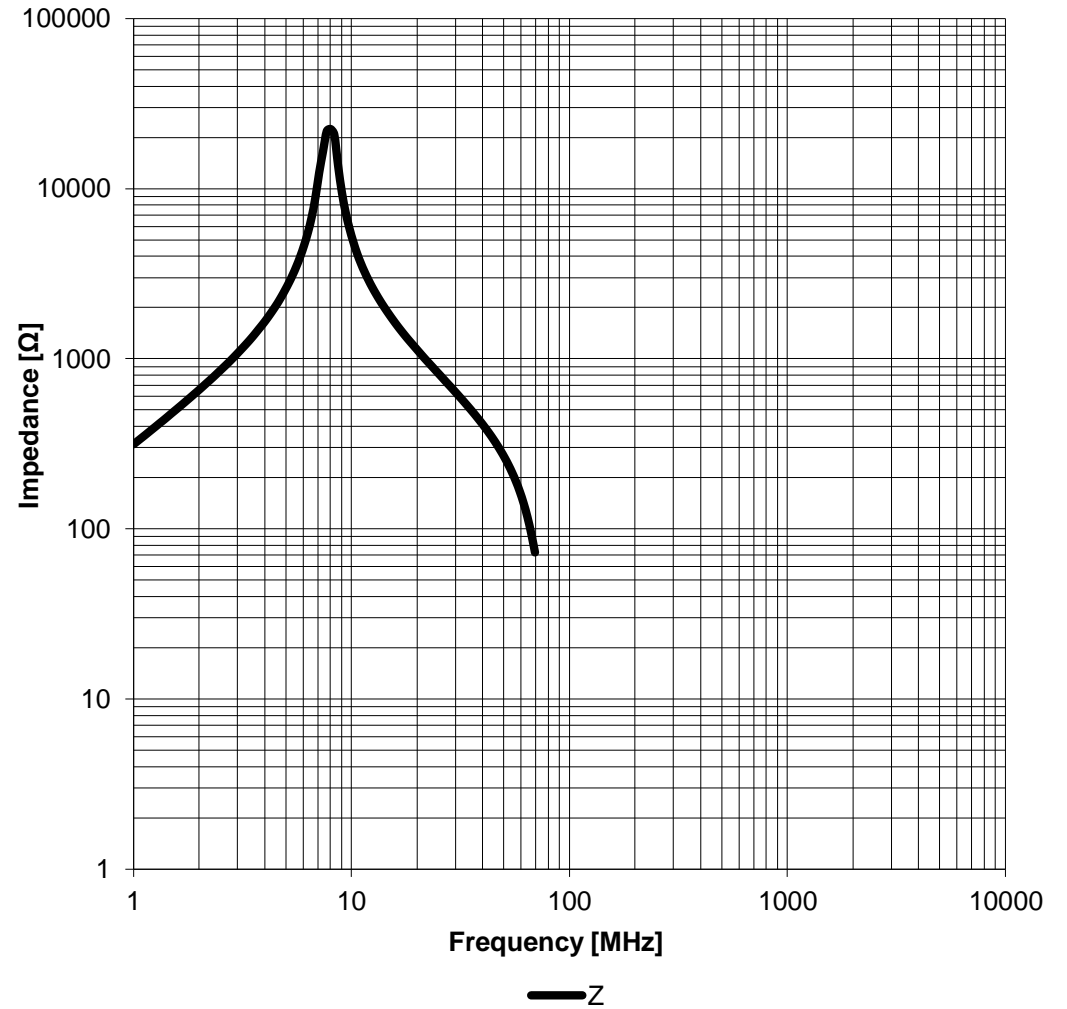

Typical Inductance vs. Current Characteristics:



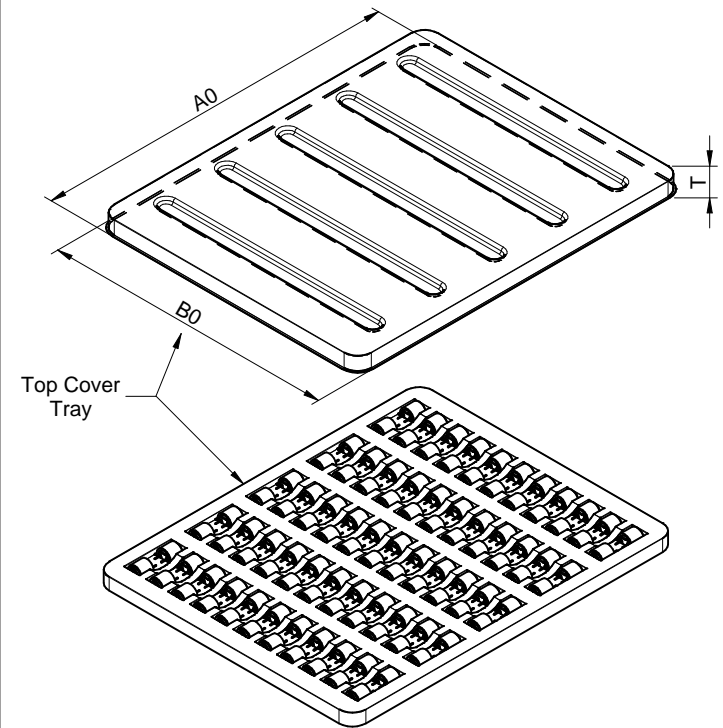
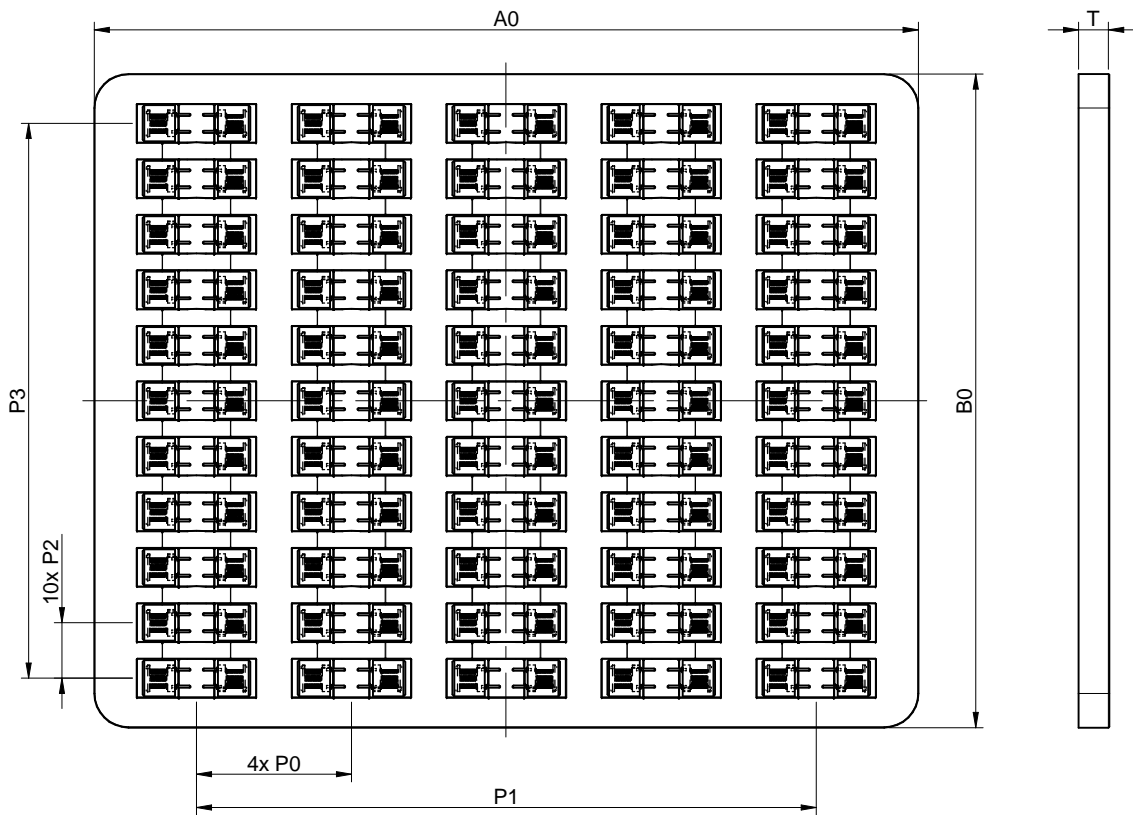
Typical Impedance Characteristics:

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.



Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.

- Strong force and high accelerations of the component size 1111 might have the effect of damage the electrical connection or to harm the circuit board due to the heavy weight of the component. These damages will void the warranty.

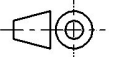
